CIRCULAR

Sub: Exemption of EDP training to disburse loan under PMEGP reg.

It is to inform that, Ministry of MSME has reviewed the performance of PMEGP scheme and the proposal for extending the exemption of EDP training to claim the Margin Money under PMEGP. Accordingly, the Ministry vide letter dated 03.10.2019 has conveyed the approval for extending the exemption of EDP training for claiming the Margin Money under PMEGP till 31.10.2019. The said exemption will facilitate the financial bank to disburse the first installment of loan and claim/upload Margin Money subsidy on the PMEGP online portal without waiting for completion of EDP training and to achieve 100 days target for the year 2019-20. All the pending EDP trainings pertaining to cases sanctioned up to 31.10.2019 shall be completed up to 31st December 2019.

2. It is, therefore requested that, the above directives may be taken note for compliance and requested to ensure that, the 100 days target for 2019-20 is achieved by all concerned.
